MEMORANDUM OF UNDERSTANDING
on Educational Cooperation
BETWEEN
Education Department, New Taipei City Government
Republic of China (Taiwan)
AND
ABC Unified School District
Cerritos, California
United States of America

Education Department, New Taipei City Government, Republic of China (Taiwan) and The ABC Unified School District, State of California, United States of America, hereinafter referred to as "the Parties," agree to enter into a Memorandum of Understanding on Educational Cooperation, hereinafter referred to as "MOU" in order to contribute positively to the strengthening of global, international education and learning – related linkages, and have reached the following understanding:

ARTICLE 1

Both Parties will endeavor to carry out the following exchanges and cooperative activities:

- (a) The promotion of educational and academic and cultural exchanges to share experiences and ideas;
- (b) Exchange of academic information, materials and publications related to education and training;
- (c) Support and promote educational exchanging and visiting and close partnerships among schools for both sides; and,
- (d) Any other academic and educational cooperative activities that may be jointly decided upon by the Parties.

ARTICLE 2

Specific details of other activities concerning mutual cooperation will be subject to further discussions and agreement between the Parties.

ARTICLE 3

Each party is responsible for the costs incurred in carrying out exchanges and other cooperative activities under this MOU, unless otherwise agreed between the Parties.

ARTICLE 4

This MOU will come into effect on the date of signature. Either party may notify the other in writing of its intention to terminate this Agreement at least six (6) months prior to the expiration of this MOU.

ARTICLE 5

Each party shall designate a liaison officer to develop and coordinate specific activities or programs. The terms and necessary budget for each program and activity to be implemented under the term of this agreement shall be mutually discussed and agreed upon in writing by both Parties prior to the initiation of a particular program or activity, and such program and activity shall be negotiated on an annual basis.

New Taipei City Government should pay \$1,500 to the ABC Unified School District for the New Taipei City Student International Study Tour Program.

ARTICLE 6

This MOU may be revised or modified by mutual consent of the Parties.

ARTICLE 7

The termination of this arrangement will not affect the duration and validity of any programs or activities which are in progress at the time of the notification of such termination.

This MOU is hereby signed by the mandates of the Parties.
